### Outlook Riverview Golf Club Annual General Meeting December 3, 2019 7:00 pm

In attendance: Board: Mario Chabot, Shane Sayers, Maury Ziegler, Blake Taylor, Aaron Gross, Ken Morrow and Tori Anholt Members: Norma Duke, Jim Currie, Laurie Burnett, Kevin Harcourt, Ed Firerichs, Sandra Derdall, Brian Kimble, Kelly Hogan, Barb Johnston, Denny Johnston, Matt Bang, Wendy Ball, Glenn Annand Chairman Mario Chabot called the meeting to order at 7:05 pm.

- 1. Motion to adopt the agenda Aaron Gross and Glen Annand carried.
- 2. Motion to accept the 2018 AGM minutes as presented. Ken Morrow and Blake Taylor carried.
  - 3. Business arising from the minutes none.
- 4. The financial 2019 year to date statement was reviewed by the board. Glen asked about the lack of tournament line from previous years. Hannah answered with how the new program separates the tournament revenue and expense so there is no need to have that line anymore. It was noted that the cart paths were not one due to other expenses that arose such as the pump breaking down. Cart paths are no slotted for the 2020 season. Ken Morrow mentioned how the current board would like to have a reserve of \$100 000.00 set aside for a just in case situation arose. This money would not be allowed to be spent unless members voted on a proposal. This would be a change in the bylaws and the members would need to have a vote on this bylaw change and will happen in the spring/summer. Motion to get an annual review done by Rosetown Accounting. Glen Annand, Wendy Ball carried. Motion to adopt the 2020 budget as circulated. Brian Kimble and Sandra Derdall carried.
  - 5. Clubhouse manager report as circulated. Course Manager report as circulated. It was asked how the increasing town water rates would affect the golf course. Options were suggested like drilling our own well. The board is well aware of the increase in water rates and although the town in not currently looking at us to pay, we will be metered in the 2020 season. We as a board need to know what we are up against as far as a water bill before we make any big decision. We have extended contracts with both Hannah and Jordan for 3 years vs the just 1 year.
- 6. 2020 event schedule was presented by Maury. Motion to accept the 2020 event schedule. Wendy Ball and Matt Bang carried.
  - 7. Old Business: none.
- 8. Mario stated that the terms were up for the following board members: Maury Zielger, Tori Anholt, Elaine Nadeau, Shane Sayers and Ken Morrow. Ken Morrow chose to step down. Elaine Nadeau needs to remain on the board due to the legal issues that are still pending from previous years. Maury, Tori and Shane will let there names stand. Maury Ziegler nominated Tori Anholt (present). Blake Taylor nominated Maury Ziegler (present). Aaron Gross nominated Shane Sayers (present). Maury Zielger nominated Melanie Harris (not present). Mario says she will let her name stand. Tori Anholt nominated Wendy Ball (present). Motion to close nominations by Glen Anannd. Barb Johnston. carried. Election is held. Spots are claimed by Shane Sayers, Maury Ziegler, Tori Anholt and Melanie Harris.
- 9. New business: Do we need to address drainage issues? Is a driving range a possibility? Or even a warm up net installed? Could a cart shed be considered especially for electric carts? Pancake hill was mentioned as a spot if the park would strike a deal with the course. It was mentioned that our bank fees are quite high and Wendy Ball said that there are cheaper options available and would get together a package for us to look over.

It was great to have put in place our new Point of Sale, Website and Online Booking in 2019. This was a much used program in 2020 and certainly helped us with maintaining the restrictions in place and ensuring all bookings were accurate.

As reflected in our Green Fees, the public traffic at the course this season was high. We had a lot of positive feedback about the course and we truly hope that these are returning customers in the years to come.

#### 2020 Clubhouse and Course Updates:

Exterior painting was done (front fence and ramp railing, side door, railway ties along first part of power cart storage, outdoor locker shed, patio benches, white portion of ceiling on patio.)

New Patio Tables & Chairs were purchased.

A toilet in the ladies room was replaced in the spring due to a cracked tank.

Cart extension was completed to allow for 20 power carts.

The 10 white power carts were auctioned and sold for a total of \$29,761.00

The remainder of the lease for the 10 blue power carts that the ORGC acquired in 2017 will be paid out in spring 2021 and the club will own those carts.

10 new power carts have been ordered for spring 2021.

The Rough Mower lease was completed in 2020.

A 2012 Toro 5410 Fairway Mower was purchased at a cost of \$17,850.00 in October.
